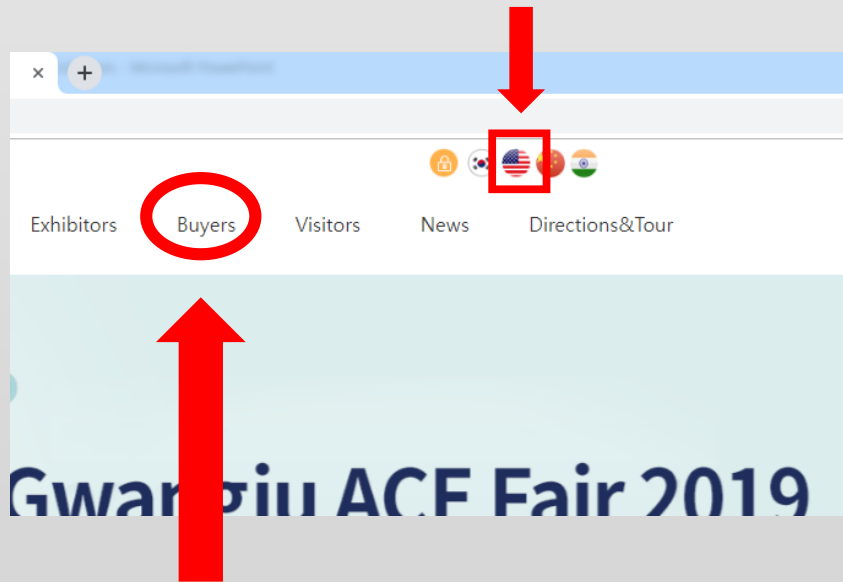

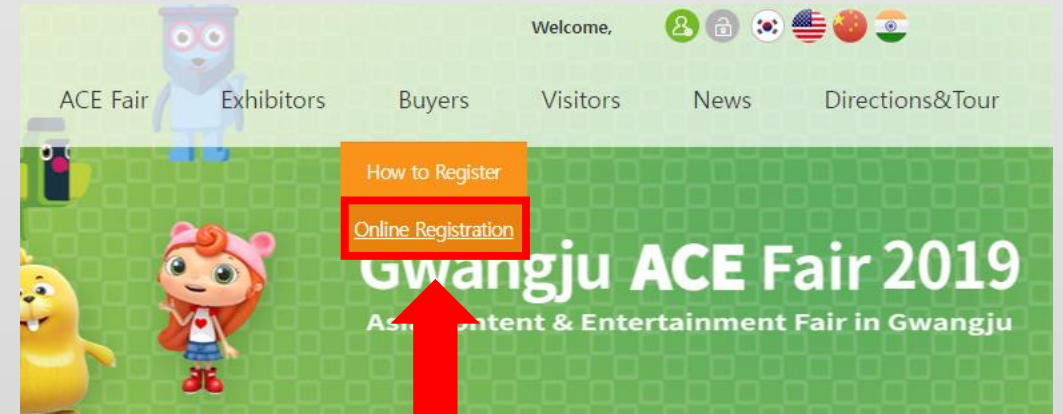

Q4. When will Biz-matching become available?

A4. 4 weeks before ACE Fair begins
